I also knowingly assume all risks whether known or unknown, of participating in the lesson or clinic as an auditor or spectator. I release Mitch & Anita Miller, host facility and sponsors, and their agents and employees from all liability for any act of negligence or want of ordinary care. In consideration of my participation in this lesson or clinic, I waive, release and discharge Mitch & Anita Miller, host facility and sponsors, and their agents, employees, representatives, heirs, executors, and assigns from any and all claim or liability for injury to myself, my animals or my property arising out of my participation in this lesson or clinic. This agreement is binding on my executors, heirs, and assigns. I agree that I will defend, indemnify and hold harmless, Mitch & Anita Miller, host facility and sponsors, and their agents and employees against all claims, demands, and causes of action, including court costs and actual attorney fees, arising from my proceeding or lawsuit brought by me or prosecuted for my benefit or on my behalf, in which this release is upheld. I acknowledge that I have read this release of liability and that I know and understand its contents.

I understand and agree that Mitch & Anita Miller DBA My Friend's Barn, its owners, agents and employees may refuse to allow and prohibit or stop any activity deemed improper or unsafe but will not be held liable for any act of negligence, resulting in accidents, damage, injury or illness to myself, my children or others, for whom I have assumed responsibility, my, or their property, including the horse (s) which I, or they, may ride.
